<p>The daily camper rate is \$30/camper per night. Please note that Pilot Lake has a \$1000 per night minimum lodging fee. Therefore, if there are fewer than 34 individuals in your group, the \$1000 minimum will be charged per night.</p> <p>For your planning purposes, we have 7 cabins which sleep 8-10 people each. We also have accommodations for 26 above our Chapel in the Lodge.</p>

Life Guard Information

Each group must inform us if they will be bringing a certified Life Guard or whether they would like Pilot Lake to provide one. To reserve a lifeguard, call to prearrange at least two weeks prior to your camp. The cost for a lifeguard is \$25/hour (minimum of 3 hours).

There is a \$100 Boat Rental fee which covers your entire stay. Includes use of lake boats and life vests.

Payment

A \$1000 deposit and this signed contract will officially confirm your reservation at Pilot Lake Wilderness Camp. If your camp must be canceled for any reason, \$500 of this deposit is non-refundable. Please make your check payable to Pilot Lake Camp and mail to Pilot Lake Camp: c/o Director Rick Drefs, 1731 Casa Nueva St., Woodland, CA, 95695.

The Balance of the total retreat amount must be paid in full to Pilot Lake Camp (Regular Baptist Camp, Inc.) before the closing session of the retreat. Extra charges will be billed if they occur. By signing this contract, please understand that you are responsible for any damage to the property beyond ordinary wear caused by a member or members of the group.

Other Remarks

An open fire is permitted in the Campfire Circle near the lake only.

All campers will pay the full amount per night.

The health department requires that your Medial Personnel and Life Guard have current certification. Also, an adult chaperone is required during all waterfront activities.

Please bring signed registration/medical release forms for every camper. This form is available on our website, www.pilotlakewildernesscamp.com. No campers will be permitted to stay without a completed registration/release of liability form. There are no exceptions to this policy.

Also please note that Pilot Lake Camp shall not be held responsible for the actions of the personnel your group brings to run your retreat program. Please take care to carefully screen the counselors and staff serving your group.

Hold Harmless

By your signature below, you shall hereby indemnify and agree to hold Regular Baptist Camp, Inc. free and harmless from any and all losses, damages, claims, demands, liability, causes of action or judgments of any nature caused in any way by us. You also bear responsibility for providing adequate insurance coverage for your group.
